SERVICE FEE SCHEDULE:

The alarm permit holder is allowed five (5) false alarms <u>free of charge</u> within a twelve (12) month period, commencing on the date of alarm permit issuance. The following service fee will be assessed the alarm permit holder on each subsequent alarm to which the police department responds by arriving at the scene of the alarm system activation, and finding it to be false, during that same twelve (12) month period.

NON-RESIDENTIAL \$30.00 per response

AN ALARM PERMIT MAY BE DENIED OR REVOKED FOR FALSE OR INCOMPLETE STATEMENTS MADE UPON THIS APPLICATION. THE PERMIT MAY ALSO BE REVOKED FOR NON-COMPLIANCE AND/OR NON-PAYMENT OF SERVICE FEES OWED TO THE CITY OF PASADENA IN ACCORDANCE WITH ORDINANCE NO. 92-194. IF YOUR ALARM SYSTEM IS MONITORED BY AN ALARM COMPANY, YOU MUST IMMEDIATELY NOTIFY THEM OF YOUR PERMIT NUMBER WHEN RECEIVED. PERMITS ARE VALID FOR TWO (2) YEARS FROM DATE OF ISSUANCE.

Dear Alarm System User:

This is to notify you of Pasadena City Ordinance No 92-194 requiring alarm systems permits and establishing other related regulations. All owners, agents or persons in control of property located inside the city limits of Pasadena, Harris County, Texas operating an alarm system to detect an unauthorized intrusion, burglary, robbery, or similar emergency must apply for and obtain an alarm permit from the City of Pasadena.

Alarm system users who had such an alarm in operation on or before 12/16/1992 have 180 days from that date to comply with the aforementioned ordinance by submitting the completed alarm application and obtaining a permit through the Pasadena Police Department Code Enforcement Division. All others must make application immediately.

In addition to the required permit, the ordinance provides for the following:

- 1. alarm permits are not required for fire or motor vehicle alarms; and
- audible alarms are to have an automatic shut off feature which provide a maximum of 30 minutes emission on an audible signal; and
- 3. alarm permits are not transferable to another person, entity or location; and
- 4. alarm permits may be denied or revoked for violation of the alarm ordinance (No 92-124); and
- service fees may be assessed for false alarms in excess of five (5) in a 12-month period.False alarms do not include the following:
 - alarm activation relating to hurricanes, tornadoes, lightning, earthquakes or gale force winds or higher; and
 - b. alarm activation which directly or indirectly generates a response from police which is cancelled prior to their arrival at the alarm site.
